The medical report is a third party report and the employer / insurance company who requested the report is the Data Controller.

You should put your request to access the report in writing to The Data Controller. This is normally the HR Manager in a workplace or the Health Claims Assessor in an insurance company.

Medwise is the Data Controller for the remainder of the medical records including handwritten consultation notes, consent forms, registration forms, medical correspondence and results of investigations. If you wish to access these records please put your request in writing (subject access request) to Medical Director of Medwise.

Please note that the right of access to medical information is restricted in some exceptional circumstances, where the health and mental wellbeing of an individual may be affected by obtaining access to the data. In addition, there are some other limited circumstances whereby the Data Controller may withhold information. Further details on these points and the Data Protection Acts can be obtained from:
